Consult with legal counsel to obtain legal advice regarding a matter of multi-party litigation and the City's potential involvement in such litigation.

THE AUTHORITY FOR HOLDING THIS CLOSED SESSION IS SET FORTH IN SUBSECTION 3-305(b)(1)(i)-(ii)&(b)(7) OF THE GENERAL PROVISIONS ARTICLE OF THE ANNOTATED CODE OF MARYLAND. THE CLOSED SESSION WILL BE HELD IN THE MEETING ROOM OF THE CORBIN STUDIO & GALLERY, AT WHICH TIME THE PUBLIC CAN OBSERVE THE MOTION TO CONVENE IN CLOSED SESSION, ANY DISCUSSION RELATED THERETO, AND THE VOTE TO CONVENE IN CLOSED SESSION AS NOTED ABOVE.
