NOTICE OF WORK SESSION

Wednesday, October 9, 2019 at 4:00 p.m.

ON WEDNESDAY, OCTOBER 9, 2019, AT 4:00 P.M., THE MAYOR AND CITY COUNCIL OF THE CITY OF CRISFIELD WILL HOLD A WORK SESSION IN THE MEETING ROOM OF THE STRATTON-CORBIN LIBRARY, LOCATED AT 4 EAST MAIN STREET, CRISFIELD, MARYLAND 21817. THE PURPOSE OF THIS WORK SESSION, AND THE ONLY ITEMS OF BUSINESS ON THE AGENDA, ARE AS FOLLOWS:

1. DISCUSSION BETWEEN THE MAYOR, THE CITY COUNCIL AND CITY OFFICIALS REGARDING THE PROVISIONS OF A RESOLUTION, TO BE DRAFTED FOR THE CONSIDERATION OF, AND VOTE BY, THE CITY COUNCIL AT A FOLLOWING MEETING OF THE MAYOR AND CITY COUNCIL, AUTHORIZING THE CREATION OF A NEW APPOINTED COMMISSION OF THE CITY OF CRISFIELD MUNICIPAL GOVERNMENT TO ADVISE, REVIEW AND STUDY MATTERS RELATING TO, INCLUDING POTENTIAL SOURCES OF, ECONOMIC DEVELOPMENT WITHIN THE CITY OF CRISFIELD. AT THE WORK SESSION, THE MAYOR AND CITY COUNCIL WILL DISCUSS THE POTENTIAL NAME FOR, THE SCOPE AND AUTHORITY OF, AND THE PROCEDURES FOR APPOINTMENT TO THIS NEW MUNICIPAL COMMISSION, TO DETERMINE WHETHER THERE IS CONSENSUS AMONG THE CITY COUNCIL ON SUCH MATTERS, FOR PURPOSES OF THE RESOLUTION THAT WILL BE PREPARED (IF THERE IS CONSENSUS AMONG THE CITY COUNCIL) TO ESTABLISH AND AUTHORIZE THIS NEW MUNICIPAL COMMISSION, WHICH WILL BE CONSIDERED FOR A VOTE BY THE CITY COUNCIL AT A SUBSEQUENT REGULAR MEETING OF THE MAYOR AND CITY COUNCIL.

2. REVIEW BY THE MAYOR AND CITY COUNCIL OF THE EVALUATION OF CITY ROADWAYS COMPLETED BY THE CITY ADMINISTRATION, AND DISCUSSION BETWEEN THE MAYOR, THE CITY COUNCIL AND CITY OFFICIALS REGARDING SUCH EVALUATION, TO DETERMINE WHETHER CONSENSUS EXISTS AMONG THE CITY COUNCIL FOR THE APPROVAL AND AUTHORIZATION OF REPAIRS AND/OR OTHER IMPROVEMENTS TO CERTAIN CITY ROADWAYS. IF THERE IS CONSENSUS AMONG THE CITY COUNCIL, THEN DISCUSSION BETWEEN THE MAYOR, THE CITY COUNCIL AND CITY OFFICIALS WILL FOLLOW TO DETERMINE THE EXTENT AND SCOPE OF SUCH REPAIRS AND/OR OTHER IMPROVEMENTS TO BE COMPLETED FOR THOSE CITY ROADWAY(S) AGREED TO BY THE CITY COUNCIL, AS WELL AS THE PROCESS FOR SELECTING A CONTRACTOR (IF ANY) TO PERFORM THE APPROVED REPAIRS AND/OR OTHER IMPROVEMENTS, INCLUDING THE TIMELINE FOR COMPLETING SUCH WORK.

THIS WORK SESSION WILL BE OPEN TO THE PUBLIC AND THE PUBLIC IS INVITED TO ATTEND THE WORK SESSION. PUBLIC COMMENT WILL FOLLOW COMPLETION OF THE MAYOR AND CITY COUNCIL'S DISCUSSION OF ITEMS REFERENCED ABOVE. THE TIME FOR PUBLIC COMMENT IS SUBJECT TO LIMITATION APPROVED BY THE MAYOR AND CITY COUNCIL; PROVIDED, HOWEVER, ANY TIME RESTRICTION FOR PUBLIC COMMENT SHALL BE APPLIED UNIFORMLY TO ALL PERSONS DESIRING TO SPEAK DURING THE PUBLIC COMMENT PORTION OF THE WORK SESSION.

AT ALL TIMES, DURING THIS WORK SESSION, THE MAYOR AND CITY COUNCIL RESERVE THE RIGHT TO CONVENE IN CLOSED SESSION FOR ANY PURPOSE AUTHORIZED BY THE PROVISIONS OF MD CODE, GENERAL PROVISIONS, § 3-305.
