1. Interested parties should submit a sealed bid to the offices of City Hall located at 319 W. Main Street, Crisfield, Maryland 21817, c/o City Manager, Rick Pollitt, on or before 4:00 p.m. Monday, January 9, 2017.
2. All bids should be clearly marked as “**Sealed Bid for 328 W Main Street**” or “**Sealed Bid for 329 Cove Street**” and shall be signed by the prospective purchaser.
3. There is no deposit requirement for the proposed bid price.
 - a. The minimum bid for 328 W. Main Street is **Three Thousand Dollars and 00/100 (\$3,000.00)**.
 - b. The minimum bid for 329 Cove Street is **Two Thousand Five Hundred Dollars and 00/100 (\$2,500.00)**. Including within the conveyance of 329 Cove Street is one (1) EDU, provided that the prospective purchaser maintains all charges when due for said EDU.
4. All Sealed Bids shall be opened at 4:30 p.m. on Monday, January 9, 2017 at the offices of City, at which time and place the names of the prospective purchasers will be read aloud.
5. The City reserves the right to reject any and all bids.
6. Notice of acceptance or rejection of any bids shall be announced at the January 11, 2017 meeting of the Mayor and Council, the next public session of the Mayor and Council, or until such later date as determined by the Mayor and Council.
7. Settlement shall occur within sixty (60) days of the acceptance of the bid.
8. The Seller makes no warranties as to the title of the properties and the properties are sold in an “As Is”, “Where Is” condition.

9. Costs of documentary stamps, all closing costs, agricultural tax (if required), shall be at the expense of buyer.
10. Taxes to be pro-rated at time of settlement.
