Public Hearing for an Ordinance Amending Chapter 112 of the City of Crisfield Municipal Code, Titled “ZONING”, by Deleting Chapter 112 in Its Entirety and Replacing It with a New Chapter 112, Titled “ZONING”; and, which further, Replaces the City of Crisfield’s Official Zoning Map with a New Official Zoning Map of the City of Crisfield

In accordance with Section 112-13(C) of the Crisfield City Code, notice is hereby given that the Mayor and Council of the City of Crisfield will hold a Public Hearing for the second and final reading of an Ordinance amending Chapter 112 (“Zoning”) of the Crisfield City Code by deleting Chapter 112 in its entirety and replacing it with a new Chapter 112 (“Zoning”) (attached as **Exhibit A** to the Ordinance). Additionally, the Ordinance, which is the subject of this Public Hearing, provides for the replacement of the City of Crisfield’s Official Zoning Map with a new Official Zoning Map of the City of Crisfield (attached as **Exhibit B** to the Ordinance). The Ordinance is intended to adopt the rewrite of Chapter 112 (“Zoning”) of the Crisfield City Code, and to adopt the rewrite of the Official Zoning Map of the City of Crisfield, as recommended unanimously by the City of Crisfield Planning Commission.

The Mayor and Council will hold the Public Hearing on Wednesday, November 14, 2018, during the regularly scheduled Mayor and Council Meeting commencing at 6:00 p.m. in the Meeting Room of City Hall. The Public Hearing will be held during the Open Session portion of the Mayor and Council Meeting, at approximately 6:15 p.m. and immediately prior to the aforesaid Ordinance being called for second and final reading. The purpose of the Public Hearing is to hear opponents and proponents of the proposed Ordinance, if there be any, and citizens are invited to testify at the Public Hearing.

Written comments regarding the proposed Ordinance may be submitted to City Hall, c/o Valerie Swift, in advance of the Public Hearing, and questions regarding the proposed Ordinance may be directed, in advance of the Public Hearing, to Valerie Swift at (410) 968-1333. A copy of the proposed Ordinance which amends Chapter 112 (“Zoning”) of the Crisfield City Code by deleting Chapter 112 in its entirety and replacing it with a new Chapter 112 (“Zoning”), and, which further, replaces the City of Crisfield’s Official Zoning Map with a new Official Zoning Map of the City of Crisfield, including all Exhibits attached to and incorporated within the Ordinance, may be examined at City Hall during regular business hours.
